

ORDINANCE 2018-7

AN ORDINANCE AMENDING AN ORDINANCE ENTITLED
"REVISED GENERAL ORDINANCES OF THE BOROUGH OF
SURF CITY, COUNTY OF OCEAN, STATE OF NEW JERSEY,
2000" AS THE SAME IN CHAPTER 30 PERTAINS TO
"ZONING"

The Mayor and Borough Council of the Borough of Surf City do ordain:

SECTION I

Section 30-9.4 entitled *Permit and Fee*, be and is hereby amended to read as follows:

30-9.4 Permit and Fee. An application for a permit, accompanied by an application fee of thirty (\$30.00) dollars shall be made to the Zoning Officer; and a permit must be obtained prior to the erecting of any fence in any zone.

SECTION II

Section 30-10.3 entitled *Permit; Fee*, be and is hereby amended to read as follows:

30-10.3 Permit; Fee. An application for a permit, accompanied by an application fee of thirty (\$30.00) dollars shall be made to the Zoning Officer; and a permit must be obtained prior to the erecting or installation of any sign, in an zone, except signs giving only directions to or only identifying parking areas.

SECTION III

Section 30-15.4(c) entitled *Zoning Permit*, be and is hereby amended to read as follows:

30-15.4(c) Zoning Permit. Applications for a zoning permit to the Zoning Officer shall be accompanied by a fee of thirty (\$30.00) dollars.

SECTION IV

All ordinances or parts of ordinances inconsistent herewith are repealed to the extent of such inconsistency.

SECTION V

If any word, phrase, clause, section or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional,

such word, phrase, clause, section or provision shall be severable from the balance of the ordinance and the remainder of the ordinance shall remain in full force and effect.

SECTION VI

This ordinance shall take effect immediately upon adoption of the ordinance.
