Borough of Surf City Governing Body Meeting Minutes

Mayor F. Hodgson called the meeting to order, reading the following statement: in compliance with the Open Public Meetings Act of the State of New Jersey, adequate notice of this meeting of the Borough Council has been provided to three newspapers and published in the January 30, 2020 issue of the Beach Haven Times. Due to the COVID-19 pandemic, this meeting took place on a remote platform called GoTo Meeting during the regularly scheduled time. Notice of directions and call-in information were also published in the August 26, 2020 edition of the Beach Haven Times and posted on the Borough website.

All present joined Mayor Hodgson in a salute to the Flag.

Council President Klose moved to approve the regular minutes from the August 12, 2020 regular meeting. Councilman Wm. Hodgson seconded the motion. With a vote in the affirmative, the minutes were approved as presented.

AN ORDINANCE AMENDING AN ORDINANCE OF THE "REVISED GENERAL ORDINANCES OF THE BOROUGH OF SURF CITY, COUNTY OF OCEAN, STATE OF NEW JERSEY, 2000" CHAPTER 30 ENTITLED ZONING SECTIONS 30-11.2(i) & 30-15.6(c).

Councilman Hartney moved to the approve Resolution 2020-118. Councilwoman Siciliano seconded the motion. With a vote in the affirmative, the following was approved.

WHEREAS, on March 9, 2020 Governor Philip D. Murphy declared a State of Emergency and a Public Health Emergency in response to the COVID-19 pandemic: and

WHEREAS, Governor Philip D. Murphy has since issued a series of executive orders resulting in the closure or limited scope of operations to local businesses within the Borough of Surf City; and

WHEREAS, the Borough Council of Surf City found it appropriate to temporarily relax outdoor dining procedures on May 13, 2020 by Resolution 2020-87; and

NOW, THEREFORE BE IT RESOLVED by the Governing Body of Surf City that the ban of amplified music be temporarily suspended, effective immediately with the following provisions.

- 1. Outdoor amplified/live music be permitted from 11:00 am until 9:00 pm, daily.
- 2. Effective until October 15, 2020 or until terminated by Mayor or Council.

WHEREAS, the State of New Jersey will be holding a General Election in November 2020; and

WHEREAS, mail-in ballots were used predominantly in the Primary Election in July 2020; and

WHEREAS, the practice of using mail-in ballots for all registered voters caused concern for voter fraud, voter disenfranchisement, postal delivery delays, significant increase in election costs, and reliance on flawed DMV/voter data computer registration data base and resulted in significant delays in counting of ballots; and

WHEREAS, well before the COVID-19 pandemic, New Jersey law permitted vote by mail for any reason or no reason at all, allowing any voter, even remotely concerned about the inperson voting option to request a mail-in ballot thus enhancing their voter choice; and

WHEREAS, numerous voters have expressed a desire to cast their ballot electronically, in-person; and

WHEREAS, the Governing Body of the Borough of Surf City feels strongly that the voter "choice" should refer to "how" to vote, not just "who" to vote for in a given election cycle.

NOW, THEREFORE, BE IT RESOLVED that the Governing Body of the Borough of Surf City, County of Ocean opposes the predominant use of mail-in balloting in the General Election in November 2020 and in all future elections.

BE IT FURTHER RESOLVED that the Governing Body of the Borough of Surf City, County of Ocean urges the Secretary of State and County Clerks to utilize in-person machine voting, in conjunction with mail-in balloting, in the General Election of 2020 and in all future elections.

BE IT FURTHER RESOLVED that the Municipal Clerk forward a certified, true copy of this resolution to the Board of Ocean County Freeholders, the Legislative Delegation for this

district, the Speaker of the General Assembly, the President of the New Jersey State Senate, the New Jersey Secretary of State and the Governor of the State of the New Jersey.

RESOLUTION OF THE BOROUGH OF SURF CITY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AWARDING A CONTRACT TO SHORE TOP CONSTRUCTION CORPORATION FOR THE 2019 ROAD RECONSTRUCTION PROJECT (4TH STREET – BARNEGAT AVENUE TO SHORE AVENUE AND 7TH STREET – BARNEGAT AVENUE TO BULKHEAD).

WHEREAS, the Borough of Surf City duly advertised for the receipt of bids for the 2019 Road Reconstruction Project (4th Street – Barnegat Avenue to Shore Avenue and 7th Street – Barnegat Avenue to Bulkhead); and

WHEREAS, in response to the invitation to bidders, four (4) bids were received on September 3, 2020; and

WHEREAS, the bids were reviewed by the Borough Engineer and it has been determined that Shore Top Construction Corporation has submitted the lowest responsible bid in accordance with the bid specifications, said bid being \$437,309.50; and

WHEREAS, it is the desire of the governing body to award a contract for the 2019 Road Reconstruction Project (4th Street – Barnegat Avenue to Shore Avenue and 7th Street – Barnegat Avenue to Bulkhead to Shore Top Construction Corporation, the lowest responsible bidder.

NOW, THEREFORE BE IT RESOLVED by the governing body of the Borough of Surf City, County of Ocean, State of New Jersey, as follows: 1. <u>R.S.</u> 52:27 BB-52: A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office.

WHEREAS, a corrective action plan, if applicable, outlining actions to be taken to correct the item listed in the comments and recommendations of the Auditor has been prepared in accordance with the law and is on file and available for public inspection in the office of the Municipal Clerk.
