

**Borough of Surf City
Governing Body Meeting Minutes**

Mayor F. Hodgson called the meeting to order, reading the following statement. In compliance with the Open Public Meetings Act of the State of New Jersey, adequate notice of this meeting of the Borough Council has been provided to three newspapers and published in the Beach Haven Times on January 12, 2023.

Roll call reflected the following members present: Councilman Peter M. Hartney, Councilman John D. McMenamin, Councilman James B. Russell, Councilwoman Jaqueline L. Siciliano & Mayor Francis R. Hodgson. Absent: Council President William D. Hodgson and Councilman Gerry P. Little.

Councilman Hartney moved to approve February 8, 2023, regular minutes. Councilwomen Siciliano seconded the motion. With a vote in the affirmative, the minutes were approved.

Councilman Little was present at 7:30 pm.

Mayor F. Hodgson provided the January 2023 Chief Financial and Municipal Court Reports.

Councilman McMenamain provided the February 2023 sanitation report. He then moved to approve Resolution 2023-59. Mr. Russell seconded the motion. With a vote in the affirmative, Resolution 2023-59 was approved, as attached.

Councilman Russell reported that the lifeguard program is up and running – uniforms have been ordered. The lifeguard in the training program is already booked for the 2023 season. The first session has forty-six kids, and the second session has forty-seven. We have new playground equipment coming. He thanked the Borough administrator for her work obtaining grants. He moved to approve Resolution 2023-60. Mr. Hartney seconded the motion. With a vote in the affirmative, Resolution 2023-60 was approved, as attached.

Councilwoman Siciliano shared that on Tuesday, February 28, 2023, we had a public meeting to answer questions about the upcoming road reconstruction project on N. 1st Street, N. 3rd Street, and Shore Avenue. The administrator did a great job arranging the meeting. The Borough engineer answered all questions submitted in advance and additional questions at the meeting. The schedule for road work is weather dependent. The website has a new link for current road projects. She thanked the administrator for doing a great job on the web page. The sinkhole on Division was completed over the course of several days by the Ocean County Road Department. The N. 8th Street plans have been submitted to the NJDOT for approval. Once that occurs, we can advertise for bids for the N. 8th Street project. Councilwoman Siciliano moved to approve Resolution 2023-61. Councilman McMenamain seconded the motion. With a vote in the affirmative, Resolution 2023-61 was approved, as attached.

Councilman Hartney stated that the beaches are holding up with the weather. The DPW has gotten a good deal of dune fences up. The handicapped ramp at N. 12th Street is being repaired. Through benefactors, Surf City will host fireworks at the Bay Beach on July 3, 2023.

Councilman Little announced that water and sewer are doing pretty well. Often, we remind everyone to turn the heating system on to prevent leaking or bursting pipes. He provided the February work report and commended the Mayor and Councilwoman Siciliano concerning the

work completed on Division Street. The ability to get things done so quickly is because of the mayor's long-standing relationship with the County officials.

Requests for memorial benches were received from Mary Kate Murray and Shirley Corbett. Councilman Hartney moved to approve the Superintendent to oversee the process. Councilman Russell seconded the motion. With a vote in the affirmative, the requests were approved. March 8, 2023

Councilman Hartney stated that after the playground items were put in, the DEP and coastal – we are not allowed to do anything new. The structures are grandfathered. After Sandy, they had bathrooms and storage boxes in Belmar, and the NJDEP made them take them all out. We are very restricted in what we can do in that area.

Mayor F. Hodgson advised everyone that we are asking the attorney about that. We plan on doing the basketball courts year but may have to do it next year. The Department of Public Works took the extra sand from his lot to Bay Beach some time ago. The prosecutor's office got involved. At 18th Street, the DPW put sand down over the seaweed because some residents complained. The NJDEP gave us 24 hours to remove the sand. When someone calls us to remove seaweed, we ask them to call the NJDEP.

Tony Pace from N. 1st Street asked about the pickleball courts.

Mayor F. Hodgson explained the process.

Stacey Fuessinger from N. 3rd Street asked about adding public bathrooms in the recreational area.

Mayor F. Hodgson explained that we could consider bathrooms next year; we like to do a little at a time.

ORDINANCE #2023-04

ORDINANCE OF THE BOROUGH OF SURF CITY, COUNTY OF OCEAN, STATE OF NEW JERSEY AMENDING AND SUPPLEMENTING CHAPTER II OF THE BOROUGH CODE OF THE BOROUGH OF SURF CITY ENTITLED "INSURANCE" TO ESTABLISH NEW ARTICLE IX ENTITLED "ANNUAL REGISTRATION OF CERTIFICATES OF INSURANCE" SO AS TO COMPLY WITH THE PROVISIONS OF P.L.2022, C.92 REQUIRING MUNICIPAL INSURANCE REGISTRATION FOR CERTAIN BUSINESS AND RENTAL OWNERS WITHIN THE BOROUGH

BE IT ORDAINED by the governing body of the Borough of Surf City, County of Ocean, and State of New Jersey as follows:

SECTION I. Chapter II of the Borough Code of the Borough of Surf City entitled "Insurance" is hereby amended and supplemented to create new Article IX entitled "Annual registration of certificates of insurance" which shall read as follows:

**ARTICLE IX
ANNUAL REGISTRATION OF CERTIFICATES OF INSURANCE**

80-1. Purpose.

The purpose of this Article is comply with the provisions of P.L.2022,c.92(C.40A:10A-1 et seq) (hereinafter "Act") requiring liability insurance for business owners and rental unit owners and to annually register the Certificate of Insurance demonstrating compliance with the Act with the municipality of which the business, rental units, or multi-family units are located.

80-2. Definitions.

CERTIFICATE OF INSURANCE – A document issued by an insurance company licensed to do business in the State of New Jersey including the policy holder's name, the address of the covered property, the policy effective and expiration dates, the type of coverage, the policy limits, the policy carrier and the names of any additionally insured parties.

80-3. Liability insurance for business owners and rental unit owners required.

The owner of a business or the owner of a rental unit, or units, within the Borough of Surf City shall maintain liability insurance for negligent acts and omissions for combined property damage and bodily injury to or death of one or more persons in any one accident or occurrence in accordance with the requirements of P.L.2022, c.92 (C.40A:10A-1), and in the amounts of coverage as set forth therein.

80-4. Certificate of insurance, annual registration required.

The owner of a business, a rental unit, or rental units, located in the Borough of Surf City shall annually, by January 1 of each year, register a Certificate of Insurance with the Municipal Clerk demonstrating compliance with the provisions of P.L.2022, c.92(C.40A:10A-1) for any business, rental units, or multi-family homes.

80-5. Registration fee.

Registration of a Certificate of Insurance is subject to a mandatory administrative fee of \$5.00 payable at the time of registration.

80-6. Violations and penalties.

- A. Any person violating or failing to comply with any provision of this article shall, upon conviction thereof, be punishable by a fine of no less than \$500 and no more than \$5,000, as determined in the discretion of the Municipal Court Judge.
- B. The violation of any provision of this chapter shall be subject to abatement summarily by a restraining order or injunction issued by a court of competent jurisdiction.

SECTION 2. If any provision or portion of a provision of this ordinance is held to be unconstitutional, preempted by Federal or State law, or otherwise invalid by any court of competent jurisdiction, the remaining provisions of the ordinance shall not be invalidated.

SECTION 3. All ordinances or parts of ordinances, which are inconsistent with any provisions of this ordinance, are hereby repealed as to the extent of such inconsistencies.

SECTION 4. No provision of this ordinance shall be construed to impair any common law or statutory cause of action, or legal remedy there from, of any person for injury or damage arising from any violation of this ordinance or from other law.

AN ORDINANCE AMENDING AN ORDINANCE ENTITLED "REVISED GENERAL ORDINANCES OF THE BOROUGH OF SURF CITY, COUNTY OF OCEAN, STATE OF NEW JERSEY, 2000" AS THE SAME IN CHAPTER 7 SECTION 24 PERTAINS TO "POLICE REGULATIONS".

The Mayor and Borough Council of the Borough of Surf City do ordain:

SECTION I

Chapter 7 Section 24 be hereby amended to read, as follows.

THROUGH STREETS.

Pursuant to the provisions of N.J.S.A. 39:4-140, the streets or parts of streets described are hereby designated as Through Streets. Stop signs shall be installed on the near-right side of each street intersecting the Through Street except where Yield signs are provided for in the designation.

Barnegat Avenue	Between the Borough of Ship Bottom corporate line and 17th Street
Central Avenue	Entire length
Long Beach Boulevard	Entire length
Long Beach Boulevard Service Road	Entire length
Sunset Avenue	Between 13th Street and 16th Street
Sunset Avenue	Between 16th Street and 22nd Street

SECTION II

All ordinances or parts of ordinances inconsistent herewith are repealed to the extent of such inconsistency.

SECTION III

If any word, phrase, clause, section, or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional, such word, phrase, clause, section, or provision shall be severable from the balance of the ordinance and the remainder of the ordinance shall remain in full force and effect.

SECTION IV

This ordinance shall take effect immediately after final adoption according to law.
