Governing Body Meeting Minutes

Mayor F. Hodgson called the meeting to order, reading the following statement: in compliance with the Open Public Meetings Act of the State of New Jersey, adequate notice of this meeting of the Borough Council has been provided to three newspapers and published in the January 13, 2022, issue of the Beach Haven Times.

All present joined Mayor F. Hodgson in a salute to the Flag.

RESOLUTION OF THE BOROUGH OF SURF CITY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING AN ADDENDUM TO THE CONTRACT WITH SHORE TOP CONSTRUCTION FOR THE 2019 ROAD RECONSTRUCTION PROJECT FOR N. 4TH AND N. 7TH STREETS.

WHEREAS, a contract was previously awarded to Shore Top Construction, Inc for the 2019 NJDOT Road Reconstruction Project for N. 4th and N. 7th Streets; and

WHEREAS the original contract for said work was in an amount of \$437,309.50; and

WHEREAS the Governing Body wishes to authorize Change Order No 1, which will result in a reduction of \$12,643.47 in the contract price; and

WHEREAS this change order amounts to a total of 4.03 percent of the original contract awarded to the contractor; and

WHEREAS it is the desire of the governing body to authorize this change order.

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Borough of Surf City, County of Ocean, State of New Jersey, as follows:

1. That the Governing Body does hereby authorize the execution of an addendum to the contract with Shore Top Construction, Inc for the 2019 NJDOT Road Reconstruction Project for N. 4th and N. 7th Streets with a decrease of \$12,643.47 in the contract price.

WHEREAS, whenever a municipality operates a municipal service system for solid waste collection, or provides for regular solid waste collection service under a contract awarded pursuant to the "Local Public Contracts Law", the amount of grant monies received by the municipality shall not be less than the annual amount of recycling tax paid by the municipality except that all grant moneys received by the municipality shall be expended only for its recycling program; and

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Surf City in the County of Ocean that the Borough of Surf City hereby certifies a submission of expenditure for taxes paid pursuant to P.L. 2007, chapter 311 in 2019. Documentation supporting this submission is available at the Borough Hall and shall be maintained for no less than five (5) years from this date.

NOW, THEREFORE, BE IT RESOLVED, by the Borough Council of Surf City to provide for temporary relief to outdoor dining applicants, as follows:

1. All outdoor seating applicants with existing approved indoor seating may relocate seating outdoors.
2. All applications must be approved by the Zoning Officer, as follows:
 - a. All seating must be confined within the property lines.
 - b. A five-foot walkway must be maintained in the public right away, as per ADA requirements.
 - c. All existing documentation requirements shall be submitted with amended and new applications.
 - d. Approved tables within the right-away must be stored off the right of way at the close of business each day.
 - e. Temporary fencing shall be permitted.
 - f. Table umbrellas, tents & awnings shall be permitted. Tents & awnings must be removed upon the executive order being lifted. Tents must be properly anchored.
3. All applications must be received by May 31, 2022.
4. This provision expires November 31, 2022.
5. All persons or entities electing to pursue temporary relief in accordance with the provisions of this order are hereby given notice that the expenditure of any funds or the incurrence of any costs or issues in reliance of the provisions of the resolution shall be at their sole and exclusive expense and/or risk.
6. Except for the temporary relief set forth herein, all applicants must comply with all Federal, State, County and local laws and regulations, including zoning and general ordinances.

A RESOLUTION OF THE BOROUGH OF SURF CITY, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPROVING 2021 ADDENDUM OF THE 2015 MULTI-JURISDICTIONAL PROGRAM FOR PUBLIC INFORMATION WHICH IS PART OF THE NATIONAL FLOOD INSURANCE COMMUNITY RATING SYSTEM.

WHEREAS, the Borough of Surf City is enrolled in the National Flood Insurance Program (NFIP) to provide flood insurance for the residents of Surf City; and

WHEREAS, the NFIP provides for insurance premium discounts for communities that voluntarily take part in the Community Rating System (CRS) program that is a component of the NFIP; and

WHEREAS, the Borough of Surf City takes part in the Community Rating System and presently holds a Class 5 Rating, which the Borough's Clerk's Office strives to maintain or possibly improve; and

WHEREAS, currently the Borough's Class 5 Rating provides for a 25% discount on flood insurance for its residents and businesses; and

WHEREAS, the Borough disseminates flood hazard information that not only is beneficial to the residents through mitigation of the hazardous effects of flooding, but is also beneficial in maximizing credit in the CRS program by conforming to the Program for Public Information standard outlined in the 2017 CRS Coordinator's Manual; and

WHEREAS, all the other municipalities on Long Beach Island and Stafford Township also participate in the CRS program and are trying to maintain their flood insurance discounts for their residents; and

WHEREAS, a Multijurisdictional Program for Public Information was formulated including all six municipalities on Long Beach Island and Stafford Township to deliver consistent outreach messages to all island and Stafford Township residents; and

WHEREAS, the OEM has determined that it was necessary to create a Program for Public Information (PPI) in order to maintain the present Class 5 Rating; and

WHEREAS, the Municipal Clerk recommends the Borough of Surf City approve the Program for Public Information Amendment; and

We have leaks in the ceiling here at Borough Hall and the building needs a new roof.

Councilman Wm. Hodgson noted that \$328,000.00 in grant revenue saves pennies on the tax rate. He read the December 2022 statistical report for the police department. He also mentioned that Department of Public Works (DPW) did a great job with the snow plowing during the most recent storm.

Councilwoman Siciliano reported that the DPW has been very busy snow plowing and salty during the recent big snow storm and the crew is ready for the next snow event. Potholes continued to be repaired as needed. The pre-construction meeting for the next NJDOT Road Reconstruction Project at N. 3rd, N. 4th and Schroderer Streets was on February 10, 2022. Timing is pending the availability of materials.

Mayor F. Hodgson congratulated the Department for an excellent job cleaning the town after the most recent snowstorm. He went on to explain, that the Borough has a program for plowing the apron of the driveway for senior citizens. The DPW staff plows the town in the following order - the firehouse, emergency worker residents, streets and Borough Hall. They may need to stop to clean drains so that the water can drain. Once that is completed the staff may begin to plow the aprons of those residents signed up for the program. The staff experienced a lot of abuse during the last storm event. The Borough is the only town to offer this program, however, if the circumstances continued the program would no longer be available.

Councilman Hartney noted that DPW cleared the snow around all the fire hydrants during the last storm. The beaches maintained well during the recent storm. We are scheduled to have replenishment in 2023, he wrote a letter to Senator Cory Booker and Congressman Van Drew in relation to appropriate federal and state funding for nourishing the beach. There is a joint effort from all of the Long Beach Island towns to support the lawsuit against the proposed windmills. He is looking into filing an amicus briefing. Mr. Hartney moved to inquire with the Borough Solicitor. Mr. Russell seconded the motion.
