Introduction and First Reading by Title of Bond Ordinance 2024-01. This ordinance authorizes the spending for a new ambulance.

BOND ORDINANCE PROVIDING FOR THE ACQUISITION OF AN AMBULANCE, APPROPRIATING \$300,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$285,000 BONDS AND NOTES TO FINANCE A PORTION OF THE COSTS THEREOF, AUTHORIZED IN AND BY THE BOROUGH OF SURF CITY, IN THE COUNTY OF OCEAN, NEW JERSEY

Introduction and First Reading by Title of Ordinance 2024-02. This ordinance authorizes spending for various road reconstruction projects.

BOND ORDINANCE PROVIDING FOR ROAD RECONSTRUCTION AND IMPROVEMENTS, APPROPRIATING \$700,000 THEREFOR AND AUTHORIZING THE ISSUANCE OF \$665,000 BONDS AND NOTES TO FINANCE A PORTION OF THE COSTS THEREOF, AUTHORIZED IN AND BY THE BOROUGH OF SURF CITY, IN THE COUNTY OF OCEAN, NEW JERSEY.

Public hearing for the 2024 Community Block Development Grant to comment on ADA community development needs of the Borough of Surf City.

Resolution 2024- 25 amends the Capital Budget to provide for the reconstruction of various roads and the acquisition of a new ambulance.

Resolution 2024-26 authorizes the Tax Assessor and/or Municipal Attorney to act as agents for the Municipality in filing petitions of appeal.

Resolution 2024-27 approves the Emergency Management Council Ledger for 2024.

Resolution 2024-28 approves the Cash Management Plan for 2024.

Resolution 2024-29 authorizes the execution of a Shared Services Agreement with the County of Ocean for participation in the Schedule "C" program.

Resolution 2024-30 authorizes executing a one-year agreement with the Associated Humane Society for animal control services. There is no increase in the cost of services for 2024.

Resolution 2024-31 authorizes participation in the Stafford Township Cooperative Pricing System.

Resolution 2024-32 approves the application for probationary membership in the Surf City Volunteer Fire Co. submitted by Steven Nagin. Councilman Hartney and Councilman Russell must recuse themselves from this item of business.
