# ORDINANCE 2025-04

AN ORDINANCE REPEALING AN ORDINANCE ENTITLED "REVISED GENERAL ORDINANCES OF THE BOROUGH OF SURF CITY, COUNTY OF OCEAN, STATE OF NEW JERSEY, 2000," AS THE SAME IN CHAPTER 11, PERTAINS TO "BUILDING AND HOUSING."

The Mayor and Borough Council of the Borough of Surf City do ordain:

### **SECTION I**

Chapter 11 Section 1.2 (a)(6) is hereby repealed;

6. The fee for roofing or siding in R-3 and R-4 uses shall be \$100.

Chapter 11 Section 1.2 (a) (7)(8) are hereby renumbered and read as follows:

- 6. Pools:
  - (a) Above ground, the fee shall be \$35.
  - (b) In-ground, the fee shall be \$250.
  - (c) Commercial, the fee shall be \$250.
- 7. The fee shall be computed as an alteration for Bulkheads, docks, wharves, and piers.

Chapter 11 Section 1.2 (f)(8) be amended as follows:

8. Fee for a Certificate of Occupancy: \$100

## **SECTION II**

All ordinances or parts of ordinances inconsistent herewith are repealed to the extent of such inconsistency.

## **SECTION III**

If any word, phrase, clause, section, or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional. If such words, phrases, clauses, sections, or provisions shall be severable from the balance of the ordinance, the remainder shall remain in full force and effect.

## **SECTION IV**

According to law, this ordinance shall take effect immediately after final adoption.
