Governing Body Meeting Minutes

Mayor F. Hodgson called the meeting to order, reading the following statement. In compliance with the Open Public Meetings Act of the State of New Jersey, adequate notice of this meeting of the Borough Council has been provided to three newspapers and published in the Beach Haven Times on January 9, 2025.

The roll call reflected the following members present: Councilman Joe DeBenedetto, Councilman Peter M. Hartney, Councilman Lee Lieber, Councilman Gerry P. Little, Councilwoman Jacqueline L. Siciliano, and Mayor Francis R. Hodgson. Council President Wm. Hodgson was absent.

Borough Superintendent Art Yahn and CFO Michael Gross attended.

All present joined Mayor F. Hodgson in a salute to the Flag.

Councilman Hartney moved to approve the minutes of the May 14, 2025, meeting. Councilman Little seconded the motion. With a vote in the affirmative, the minutes were approved.

The roll call reflected the following votes for approval: Mr. DeBenedetto, Mr. Hartney, Mr. Lieber, and Mr. Little. Mrs. Siciliano abstained. Mr. Wm. Hodgson was absent.

Resolutions 2025-103 to 2025-114 were approved, as attached.

Mayor F. Hodgson read the April 2025 Municipal Court and CFO reports.

Councilman Lieber presented the May 2025 police department statistical report.

Councilman DeBenedetto reported that we are ready for the season. Art Yahn & the public works crew have finished the pavers, oversaw the completion of the dock at the boat ramp, and will be installing basketball systems, hopefully by July 1st. A new pavilion at Bay Beach is scheduled to be installed in September or October, following the completion of a new concrete pad. Repairs on the windows will start soon. The contractor will start with one window for now to ensure he can accurately quote the remainder of the project. He also mentioned that dogs are not permitted in the playground area.

Councilwoman Siciliano read the DPW report for April 2025. Work on the S. 1st Street Bulkhead is underway. There will be a pause in projects for the summer due to our seasonally busy roads. She reported on a meeting she had with the NJDOT. They will be out of the area on June 20th and will return in the fall to complete the project before winter. At the meeting, the mayor had inquired about dredging. She thanked Councilman Hartney for his outstanding job organizing the Memorial Day Service.

Councilman Hartney thanked everyone who made the Memorial Day Service possible on May 24th at 11:00 a.m., from the administrative staff to the Department of Public Works. The event was well attended by the public and representatives from the 9th Legislative District, who provided a resolution for us to display in Borough Hall. Councilman Hartney provided the May 2025 beach badge report. Next month, he will present a resolution opposing proposed legislation allowing

accessory buildings as a second use. He thanked Erik Dollman and the crew for painting the fire hydrants.

Councilman Little provided the May 2025 water and sewer report. The contractor is waiting for some parts for the light on the water tower. The department assisted with road patchwork throughout the Borough. The Water & Sewer Department helps the Department of Public Works, and vice versa. The power supply was replaced at Well 7. On the agenda, we approved the bid for the booster pump. Last year, we replaced a booster pump, which was well over \$100,000.00.

Mayor F. Hodgson mentioned that the quote for this job came in almost twice the amount of the bid.

Antonella Lia requested that a bench be placed in memory of her grandfather at the 22nd Street beach. Councilman DeBenedetto moved to approve the request. Councilwoman Siciliano seconded the motion. With a vote in the affirmative, the request was approved. The roll call reflected the following votes in favor of approval: Mr. DeBenedetto, Mr. Hartney, Mr. Lieber, Mr. Litte, and Mrs. Siciliano. There were no abstentions. Mr. Wm. Hodgson was absent.

Michele Manzo requested that a bench be placed in memory of her husband at the 8th Street beach. Councilman Hartney moved to approve the request. Councilwoman Siciliano seconded the motion. With a vote in the affirmative, the request was approved. The roll call reflected the following votes in favor of approval: Mr. DeBenedetto, Mr. Hartney, Mr. Lieber, Mr. Litte, and Mrs. Siciliano. There were no abstentions. Mr. Wm. Hodgson was absent.

Councilwoman Siciliano moved to pay the bills. Councilman Hartney seconded the motion. The bills were approved for payment. The roll call reflected the following votes for approval: Mr. DeBenedetto, Mr. Hartney, Mr. Lieber, Mr. Litte, and Mrs. Siciliano. There were no abstentions. Mr. Wm. Hodgson was absent.

Mayor F. Hodgson called for any comments from the public.

John Gausz, N. 3rd Street, everyone is invited to the Surf City Taxpayers Association annual meeting and picnic on June 21st. He is requesting that the lawn be cut on Thursday or Friday. He thanked Councilwoman Siciliano and the Borough Clerk for helping him with the recent road paving and his daughter's wedding.

Lou Giele, of N. 17th Street, spoke about safety concerns he has regarding speeding and overweight trucks on N. 17th Street.

Toni DeLisio, N. 17th Street, had the same concerns about N. 17th Street.

John Hafner, of Sunset Avenue, added that many people do not use the stop sign on N. 17th Street.

Bill Hutson, trustee of Kite Vision, would like to thank everyone involved for their efforts in obtaining approvals for the kite festival.

Councilman Hartney moved to adjourn the meeting. Councilwoman Siciliano seconded the motion. With a vote in the affirmative, the meeting was adjourned. The roll call reflected the following votes for approval: Mr. DeBenedetto, Mr. Hartney, Mr. Lieber, Mr. Little, & Mrs. Siciliano. There were no nays or abstentions. Mrs. Siciliano was absent.

RESOLUTION OF THE BOROUGH OF SURF CITY, COUNTY OF OCEAN, STATE OF NEW JERSEY ENDORSING THE HOUSING ELEMENT AND FAIR SHARE PLAN

WHEREAS, by way of P.L. 2024, c. 2, the State of New Jersey has created the "Affordable Housing Dispute Resolution Program" (the "Program") within the judiciary through which the judiciary reviews and grants a certification of compliance pursuant to the Fair Housing Act, N.J.S.A. 52:27D-301 et seq., for municipalities adopting housing element and fair share plans that include the constitutional obligation to create realistic opportunities for low- and moderate-income households; and

WHEREAS, the Borough of Surf City (the "Borough") has previously adopted Resolution 2025-048 that the Borough's present need is, as determined by the calculations prepared by the Department of Community Affairs for the period from 2025 to 2035, 2 units and the Borough's prospective need is 39 units; and

WHEREAS, the Borough has filed a declaratory judgment through the Program, seeking to confirm that its need was properly calculated, and seeking a certification of compliance from the Program; and

WHEREAS, on March 27, 2025, the Hon. Sean D. Gertner, J.S.C., issued an order, confirming the Borough's need as calculated, and authorizing the Borough to prepare and adopt a housing element and fair share plan by or before June 30, 2025; and

WHEREAS, the Borough's Planning Board has directed its consultants to prepare a housing element and fair share plan as part of the master plan of the Borough, which, in part, includes an analysis of the vacant and developable land available within the Borough which would be suitable for the development of housing for low- and moderate-income households consistent with the Fair Housing Act to establish the Borough's realistic development potential ("RDP"); and

WHEREAS, the Borough is located entirely within an environmentally constrained area, due to its location on a barrier island located within the flood zone, rendering any available property not suitable for development, and therefore creating an RDP within the Borough of 0 units; and

WHEREAS, the Borough's Planning Board has, pursuant to the Municipal Land Use Law, held public hearings on the proposed housing element and fair share plan, and has adopted same at its meeting of June 11, 2025; and

WHEREAS, as a precondition to the submittal of the housing element and fair share plan to the Program for review, the Borough Council is required to endorse the housing element and fair share plan; and

WHEREAS, the Borough Council has reviewed and determined that the endorsement of the housing element and fair share plan is in the Borough's interest to fulfill its constitutional fair share obligations.

NOW, THEREFORE, BE IT RESOLVED by the Borough of Surf City as follows:

- 1. The Borough has reviewed the Housing Element and Fair Share Plan, prepared by Owen Little and dated May 28, 2025, and hereby endorses same for filing with the Program.
- 3. The Borough's special affordable housing counsel, Gibbons P.C., is hereby authorized to file the Housing Element and Fair Share Plan with the Program.
- 4. A copy of this resolution shall be posted on the municipal website of the Borough upon filing of the Housing Element and Fair Share Plan with the Program.
