Governing Body Meeting Minutes

Mayor F. Hodgson called the meeting to order, reading the following statement. In compliance with the Open Public Meetings Act of the State of New Jersey, adequate notice of this meeting of the Borough Council has been provided to two newspapers, the Asbury Park Press and the Beach Haven Times.

The roll call reflected the following members present: Councilman Peter M. Hartney, Councilman William D. Hodgson, Councilman Lee Lieber, Councilman Gerry P. Little, Councilwoman Jacqueline L. Siciliano, and Mayor Francis R. Hodgson. Councilman Joe DeBenedetto was absent. Borough Superintendent Art Yahn, Chief Jack Casella, and CFO Michael Gross attended.

All present joined Mayor F. Hodgson in a salute to the Flag.

Councilman Hartney moved to approve the minutes of the August 13, 2025, meeting. Councilman Little seconded the motion. With a vote in the affirmative, the minutes were approved. The roll call reflected the following votes for approval: Mr. Hartney, Mr. Wm. Hodgson, Mr. Lieber, Mr. Little, and Mrs. Siciliano. Mr. DeBenedetto was absent.

Councilwoman Siciliano moved to open the public hearing for Ordinance 2025-06. Councilman Lieber seconded the motion. With a vote in the affirmative, the hearing was open to public comment. The roll call reflected the following votes for approval: Mr. Hartney, Mr. Wm. Hodgson, Mr. Lieber, Mr. Little, and Mrs. Siciliano. Mr. DeBenedetto was absent. There were no comments. Councilman Hartney moved to close the public hearing. Councilman Little seconded the motion. With a vote in the affirmative, the hearing was closed to public comment. The roll call reflected the following votes for approval: Mr. Hartney, Mr. Wm. Hodgson, Mr. Lieber, Mr. Little, and Mrs. Siciliano. Mr. DeBenedetto was absent.

Councilman Hartney moved to adopt Ordinance 2025-06. Councilwoman Siciliano seconded the motion. With a vote in the affirmative, Ordinance 2025-06 was adopted. Ordinance 2025-06 increases fees for beach badges.

Hodgson, Mr. Lieber, Mr. Little, and Mrs. Siciliano. Mr. DeBenedetto was absent. There were no comments. Councilwoman Siciliano moved to close the public hearing. Councilman Hartney seconded the motion. With a vote in the affirmative, the hearing was closed to public comment. The roll call reflected the following votes for approval: Mr. Hartney, Mr. Wm. Hodgson, Mr. Lieber, Mr. Little, and Mrs. Siciliano. Mr. DeBenedetto was absent.

Councilman Hartney moved to adopt Ordinance 2025-07. Councilman Lieber seconded the motion. With a vote in the affirmative, Ordinance 2025-07 was adopted. Ordinance 2025-07 permits nonprofit organizations to use amplified sound and/or music for special events upon resolution of the Governing Body.

AN ORDINANCE AMENDING AN ORDINANCE ENTITLED "REVISED GENERAL ORDINANCES OF THE BOROUGH OF SURF CITY, COUNTY OF OCEAN, STATE OF NEW JERSEY, 2000," AS THE SAME IN CHAPTER 4, PERTAINS TO "POLICE REGULATIONS."

The roll call reflected the following votes for approval: Mr. Hartney, Mr. Wm. Hodgson, Mr. Lieber, Mr. Little, and Mrs. Siciliano. Mr. DeBenedetto was absent.

Resolutions 2025-138 to 2025-145 were approved, as attached.

Mayor F. Hodgson read the July 2025 Municipal Court and CFO reports.

Councilman Lieber presented the August 2025 police department statistical report. The Surf City Police Department will host its annual Trunk or Treat on October 25, 2025, from 5:00 p.m. to 7:00 p.m.

Councilman Hartney provided the beach patrol report for Councilman DeBenedetto. This season was the warmest for ocean temperatures. Last year was the coldest.

Council President Wm. Hodgson read the sanitary landfill analysis and recycling report for August 2025.

Councilwoman Siciliano read the Streets & Roads DPW report for August 2025. We approved nine streets for reconstruction under the ARPA funding. We will hold a pre-construction meeting with the contractor, followed by a public meeting for those affected by the construction. The 12<sup>th</sup> & 13<sup>th</sup> Street bulkheads are currently being reconstructed. On August 20<sup>th</sup>, she and Councilman DeBenedetto met with Congressman Van Drew to discuss funding for beach replenishment. He clarified some misinformation about funding and is seeking to establish a permanent fund for replenishment.

Councilman Hartney reported the beach badge sales. The 14<sup>th</sup> Season of the Bay program has ended. Over the course of the season, 390 people attended. He further explained how funding works for beach replenishment. He will reach out to the Senate for a follow-up discussion. Another area of concern is the NJ DEP PACT REAL RULE that is set to be enacted by next summer. The rule requires an additional 4 feet of elevation and includes a clause for "dry access."

This means that elevators will not be permitted to be installed below the Base Flood Elevation. The rule was created by flawed data from Rutgers instead of using FEMA data. Public comments are due by September 19, 2025.

Mayor F. Hodgson entertained a motion to submit a resolution vehemently opposing this new rule. Councilman Hartney moved to approve the motion. Council President Wm. Hodgson seconded the motion. With a vote in the affirmative, Resolution 2025-146 was approved. The roll call reflected the following votes for approval: Mr. Hartney, Mr. Wm. Hodgson, Mr. Lieber, Mr. Little, and Mrs. Siciliano. Mr. DeBenedetto was absent.

Councilman Little provided the August 2025 water and sewer report. He thanked the Mayor, Council, Administrator, Superintendent, and Water & Sewer Foreman for getting us through the summer. Well 7 has been diagnosed and addressed. We are doing a manhole inspection program. There are three employees in the water and sewer department. Two of them are enrolled in classes. Councilman Little spoke about the anniversary of 9/11. Ocean County lost 13 soldiers in the War on Terror. He has met with most of their families. Next year will be the 25th anniversary and the 250th anniversary of our country.

Mayor F. Hodgson spoke about the emergency valve work that took place on N. 2<sup>nd</sup> Avenue and provided a history of naming Schoderer Avenue.

Nancy Gillmer has requested a memorial bench to be located at N. 3<sup>rd</sup> and the Bay in memory of her parents, John and Carol Bergen. Robert Remling has also asked that a memorial bench be placed at N. 2<sup>nd</sup> and the Bay in memory of his life, Desiree. Councilwoman Siciliano moved to approve the request. Councilman Lieber seconded the motion. With a vote in the affirmative, the request was approved. The roll call reflected the following votes for approval: Mr. Hartney, Mr. Wm. Hodgson, Mr. Lieber, Mr. Little, and Mrs. Siciliano. Mr. DeBenedetto was absent.

Greg O'Connell from the Association of Surf Angling Clubs is requesting to host a fishing tournament and waive beach buggy fees for participants on October 11, 2025, from 5:30 am to 2:00 pm. Councilman Hartney moved to approve the request. Council President Wm. Hodgson seconded the motion. With a vote in the affirmative, the request was approved. The roll call reflected the following votes for approval: Mr. Hartney, Mr. Wm. Hodgson, Mr. Lieber, Mr. Little, and Mrs. Siciliano. Mr. DeBenedetto was absent.

Councilman Hartney moved to pay the bills. Councilman Little seconded the motion. The bills were approved for payment. The roll call reflected the following votes for approval: Mr. Hartney, Mr. Wm. Hodgson, Mr. Lieber, Mr. Little, and Mrs. Siciliano. Mr. DeBenedetto was absent.

Mayor F. Hodgson called for any comments from the public.

Ron Fiore asked for more information about the NJDEP PACT REAL RULE.

Mayor F. Hodgson spoke about conversations he has had with the Congressman about the flood insurance requirements. Are the rules applied to New Orleans, New York City, and the Mississippi Valley? Our area is also under further scrutiny with service line inspections. Surf City

will have to replace the lines at its own expense, while Newark received grant money for the same purpose.

Councilman Little moved to adjourn the meeting. Councilwoman Siciliano seconded the motion. With a vote in the affirmative, the meeting was adjourned. AN ORDINANCE AMENDING AN ORDINANCE ENTITLED "REVISED GENERAL ORDINANCES OF THE BOROUGH OF SURF CITY, COUNTY OF OCEAN, STATE OF NEW JERSEY, 2000," AS THE SAME IN CHAPTER 19, PERTAINS TO "PARKS, BEACHES AND RECREATIONAL AREAS."

The Mayor and Borough Council of the Borough of Surf City do ordain:

SECTION I

Chapter 19 Section 1.6 (c)(d)(e)(f) is hereby amended, as follows.

- c. Forty-five dollars per person, per season, or any fractional part thereof, of the bathing season, provided that application is made to the proper authorities on or before May 31.
- d. Fifty-five per person, per season, or any fractional part thereof, of the bathing season if the application is made after May 31.
- e. Twenty-five dollars per person, per week, or any fractional part thereof, of the bathing season.
- f. Eleven per person, per day, or any fractional part thereof, of the bathing season.

SECTION II

All ordinances or parts of ordinances inconsistent herewith are repealed to the extent of such inconsistency.

SECTION III

If any word, phrase, clause, section, or provision of this ordinance shall be found by any Court of competent jurisdiction to be unenforceable, illegal, or unconstitutional. If such words, phrases, clauses, sections, or provisions shall be severable from the balance of the ordinance, the remainder shall remain in full force and effect.

SECTION IV

According to law, this ordinance shall take effect immediately after final adoption.







## RESOLUTION 2025- 146

WHEREAS, As active partners in NJDEP's Resilient Long Beach Island initiative, our municipalities remain committed to advancing strategies rooted in both climate science and local expertise. I urge NJDEP to work with us in crafting rules that are practical, flexible, and supportive of resilient redevelopment that enhances — rather than diminishes — the safety, economic vitality, and sustainability of our island.

WHEREAS, The proposal applies the Inundation Risk Zone (IRZ) (proposed N.J.A.C. 7:13-3.6) to lands projected to be inundated by tidal flooding by 2100, combined with a Climate Adjusted Flood Elevation (CAFE) of +4 feet above FEMA Base Flood Elevation (BFE) (N.J.A.C. 7:13-12.6(b), as amended by 57 N.J.R. 1340(a)). With most of our island at a grade elevation of five feet or less, these provisions will affect nearly every property across Long Beach Island and,

WHEREAS, For barrier islands like ours, these combined standards will:

- Severely limit the ability to redevelop homes, businesses, and public facilities;
- Impose heightened construction costs beyond the reach of many property owners;
- Create unintended “no-build” situations, even after the removal of the IRZ from the 3% impervious cover limit (57 N.J.R. 1340(a), deleting proposed N.J.A.C. 7:7E-3.4(b)3); and
- Result in piecemeal elevation, where only a few properties meet the standards while neighboring homes remain significantly lower — an impractical and unsafe outcome without billions in coordinated funding to elevate the entire island simultaneously and,

WHEREAS, Responsible redevelopment — including appropriate lot fill and elevation of existing structures — has been the most effective way for our communities to reduce flood impacts for more than a decade. These proposed rules instead discourage investment and leave existing, non-compliant structures at risk, rather than encouraging mitigation or safe reconstruction and,

WHEREAS, The proposal removes Coastal Center designations and reclassifies barrier islands as Environmentally Sensitive Areas under N.J.A.C. 7:7-13.2(b), disregarding decades of coordinated planning under CAFRA and the Coastal Zone Management Rules. It also expands riparian zones into bay-side developed areas (N.J.A.C. 7:13-4.1(c)), meaning that routine property maintenance — such as bulkhead repairs, dock replacements, and vegetation management — and even minor land disturbances would now require lengthy, expensive permitting processes and,

WHEREAS, Long Beach Island is not an undeveloped barrier island tract; it is a fully developed, long-established, and high-density community with critical infrastructure, businesses, and year-round and seasonal residences. The Island must continually maintain,

upgrade, and adapt its infrastructure and properties to ensure the safety, functionality, and livability of the community for residents, visitors, and the economy that sustains it. Applying standards designed for rural or undeveloped lands is both inappropriate and unworkable and,

WHEREAS, Cumulatively, these changes will:

- Reduce property values and erode municipal tax bases, limiting funding for public safety, stormwater improvements, and shoreline protection;
- Delay or prevent critical infrastructure upgrades — including roads, utilities, and public facilities — which are essential for safe evacuation routes (N.J.A.C. 7:13-12.7(b) limits critical infrastructure in the IRZ except under narrow circumstances);
- Increase overall flood risk, as owners defer or abandon needed upgrades due to costs and regulatory uncertainty; and
- Negatively impact tourism and the economy that sustains our communities and,

WHEREAS, We urge NJDEP to revise the REAL and FHACA amendments to:

- Recognize the built status of barrier islands and preserve reasonable redevelopment allowances in N.J.A.C. 7:7 (Coastal Zone Management);
- Exclude fully developed bayfront areas from expanded riparian zone requirements (N.J.A.C. 7:13-4.1(c));
- Provide flexibility in applying CAFE standards for non-critical structures (N.J.A.C. 7:13-12.6(b)); and
- Coordinate regulatory updates with municipal master plans and hazard mitigation plans. Barrier islands such as ours are at the forefront of climate change adaptation. Achieving success will require regulations that are both practical and flexible, supporting resilient redevelopment rather than inflexible restrictions that may increase vulnerability for residents and infrastructure, and,

WHEREAS, all of these communities of Long Beach Island share the goal of improving resilience to flooding and climate change, the proposed rules are overly restrictive, misaligned with the realities of developed barrier island communities, and will create serious unintended consequences for the safety, economy, and long-term sustainability of our island, and

WHEREAS, Long Beach Island communities have been leaders in coastal resiliency and flood adaptation. Our track record shows that collaborative, science-driven, and practical approaches can deliver measurable results. The current proposal, however, threatens to undercut these efforts and impede further progress, so,

THEREFORE BE IT RESOLVED that the Mayor and Governing Body of the Borough of Surf stand in vehement opposition to the proposed rule of the REAL and NJPACT and that the rule process be terminate, the proposed rule be laid aside and,

BE IT FURTHER RESOLVED, that the State of NJ department of Environmental Protection honestly and actively engage the local communities, inclusive of the Borough of Surf City in this critical dialogue to achieve our shared goals of resilience and long-term sustainability.
